#### I. Review/Approve minutes from May 19th General Meeting

- The minutes from last meeting were approved.

#### II. President's Report – Alan Zeunen

- We currently have no GM and no Head Pro.
- We had another good year on membership, which left our budget in very good order. This year we lowered our renewal rate from \$85 to \$80, and this should not have too much impact on the budget.
- We stopped our weekday tourneys last April due to low participation.
- The 2<sup>nd</sup> Annual BBQ Tourney was another big success.
- The 12-Man team was enjoyed by the 24 players lucky enough to get on the team.
- We do not anticipate any change to how we support the NCGA qualifier events (2-Man Zone, 4-Man Zone, etc.).

##### i. Vice President's Report – Ed Sarubbi

- This year we ended with 526 members. We have 166 renewals/new members so far for next year, which is about the same or better than last year at this same time.
- The summer long match play went well this year.
- 267 members of the 526 membership participated in tournaments this year.

##### ii. Treasurer's Report – Dave Lemert

- The balance sheet and income statement for the club was handed out. We now have \$11,500 in the bank, which includes the money from renewals and new members received for 2008.
- We are currently ahead of our planned budget for 2007.

**iii. Tournament Director's Report – Roy Wold**

- The schedule for 2008 is on the website. We will have at least a couple away tournaments this year also.
- There are 56 signed up for the Turkey Shoot so far.
- We're still considering the format for the 4-Man Zone qualifier (i.e. individual, 2-man team, or 4-man team).

- The "watch list" format did get modified this year to make it a bit easier to get off the list over time. It seems to be working well now, so we don't foresee any changes needed anytime soon.
